11. REPORTS

11.1 Antelope Elementary School District Report

The District ended the school year with an enrollment of 703.

The last month was filled with field trips and special events. Antelope held its annual Folk Dance Celebration in conjunction with Grandparent's Day. There was a tremendous turn out. A thank you goes out to Mr. Boone for barbequing hot dogs and special thanks goes out to Mrs. Huskey for all of her time, effort and dedication to making this a successful event. Berrendos had several field trips that included both high honor and honor roll for the 2nd trimester along with the 8th grade visiting Sacramento State and Raging Waters. Berrendos also made it through graduation—the weather was a bit of an issue but all went well. Manton end of the year activities included Kindergarten graduation, award ceremonies, and on the last day of school the students went to the Redding Aquatic Park. The students had a great time. Plum Valley also had an end of the year award ceremony with the parent club providing gift certificates for the winners. Their last day included a trip to Shasta Caverns. Mrs. Nellums reported that all went well.

Curriculum updates: Berrendos will be adding a 7th period to their schedule. This will be either an extra intervention (in addition to the support they receive in Matador) or enrichment for those who do not need extra support. This Advisory period will fall during 4th period (the class just prior to lunch) for all students. Depending on the students' needs or interests the following classes will be offered: STEM, Coding, Spanish, Digital Publishing, EL Intervention, and Math Intervention.

Ron and his maintenance crew are hard at work remodeling the new CDS classroom. They are making good progress. The School Services report is in and should be a discussion item on the August Board Agenda. Inter-district requests are currently being reviewed and processed for the 2015-16 school year. Summer School is in full swing at both Antelope and Manton. Antelope has just over 80 students enrolled while Manton currently has 23 enrolled. Work continues on addressing the technology infrastructure for the Small Schools.

11.2 Attendance Report

Superintendent Hassay reviewed the 2014-15 attendance. The District ended the year with an average of 96.01% of actual attendance. The ADA for P2 reporting period was 680.99.
