**10. REPORTS**

**10.1 Antelope Elementary School Principal's Report**

Enrollment stands at 402 down 2 from last month. The grading period ends on Friday and report cards will go home on March 13, 2015.

Writing benchmark assessment began today. Writing is now part of the daily student schedule.

Academic and Character Awards were given out last week. School safety was also discussed along with lockdown procedures.

School safety has been a priority during the month of February. The Safety Summit held earlier this month at TCDE was very informative. Antelope teachers are now keeping their classroom doors locked as a safety measure. The teachers report that it is going well and both students and teachers are getting used to the new safety procedures.

**10.2 Berrendos Middle School Principal's Report**

Enrollment stands at 240 down a bit from last month.

First Trimester Honor Roll trips will be held this Thursday. Honors are going bowling at Lariat Bowl and High Honors are going to Viking Skate. Almost 60 percent, 143 students made honor roll.

The PE dance project has come to a close. The PE Department should be commended on all the time and patience put into making this such a successful and worthwhile unit.

Basketball has come to a successful close. Softball, baseball and track are starting up.

PIQE has been scheduled and orientation will be next week, Tuesday, March 2, at 6:00 PM.

Mrs. Pearce will be speaking tonight during the curriculum report about the reading intervention program at Berrendos. She also was recently nominated and was a finalist for the California League of Middle School Educators of the Year.

### **10.3 Manton Elementary School Administrative Designee's Report**

The basketball season has come to a close. The end of the season basketball banquet is March 12, 2015.

The Small School Science Fair will be held May 1, 2015 at the Tehama County Department of Education.

The Small School Track meet will be held at Red Bluff High School on May 8, 2015. Mr. Thomas is working with Mrs. Hendricks and Mrs. Wheeler to coordinate the event as not to disrupt their programs. CSF members and Seniors in need of volunteer time will be helping with the event.

### **10.4 Plum Valley Elementary School Administrative Designee's Report**

During February students participated in the Art Celebration held for the Small Schools sponsored by the Tehama County Department of Education. Several of the pieces are now entered in the Tehama County Art Council's art competition.

As of tomorrow, Mrs. Worley will be back full time and on Friday the third grade will receive dictionaries from the Red Bluff Rotary.

Students are continuing to work on their reading goals. Mrs. Nellums is working with the Lassen Park corporate company in hopes that they will provide T-shirts for every student who reads enough minutes to reach Lassen Peak.

### **10.5 Curriculum Report**

Mrs. Pearce, from the Learning Center at Berrendos, explained the different Matador programs at Berrendos and how they are operated. She noted how students are targeted for intervention, what curriculum is used, how assessment data is compiled, and how she and Mrs. Jacobs, the Math Matador teacher, coordinate scheduling. She is always looking for new ways to inspire student learning, she shared student notebooks that her students are working on that help reinforce how to find a topic sentences, main ideas, and themes. This project has helped her students be successful with their peers in their core classes.

### **10.6 Superintendent's Report**

Enrollment stands at 703 down 7 from last month. AES =402, BMS=239, Manton=38, Plum Valley=19 and CDS =5.

New benches and trash cans have been installed at Berrendos.

The ACSA All-Stars luncheon will be held on March 5<sup>th</sup> at the Elks Lodge. The following students have been selected: Antelope=Ashtyn Arrowsmith, Berrendos=Lindsay Harrison, Manton=Austin Ables, and Plum Valley= Forrest Fankhauser—Congratulations to all.
