## 10.1 Superintendent's Report

a.) Project Lead the Way Presentation

# 10.3 Antelope Elementary School Principal's Report

The attendance contest has concluded with Mrs. Spence's class declared the winner with a 98.58% attendance rate. Mrs. Burroughs' class came in a very close second with 98.17%, the difference of one absence. The next attendance contest will start in January.

## 10.4 Berrendos Middle School Principal's Report

Mr. Durfee and Mr. Weber attended a symposium on the Next Generation Science Standards hosted by TCDE. There were sessions on how to access the standards and implement them. It included timelines and sample activities.

Mrs. Dent and Mrs. Huskey's Performing Arts Advisory put on a great series of shows the week of November 2, 2015. The Fun Run has been postponed due to lack of registrations. Student Council attended a leadership seminar hosted by Red Bluff High School. Student Council is planning a dance for December 17, 2015. The Holiday Band concert is schedule for December 15, 2015 at 7:00 PM. Report cards will be mailed home on Friday, November 20, 2015. Planning is underway for Antelope District fall Professional Learning Community (PLCs) dates. A survey has been sent out to teachers to better assess individual as well and grade level needs.

#### 10.6 Attendance/Enrollment Report

Discussion was held on the feasibility of the district purchasing the property located adjacent to the District Office. The Board was in agreement that Mr. Hassay should pursue the purchase for the possible location of the proposed charter school, LAVA. It was agreed that even if LAVA did not materialize that the property would be very useful to the district.

## 13.3 School Services of California Efficiency Review Update

Mr. Hassay met with the staff at Manton and Plum Valley to discuss the Efficiency Review and to quell rumors of imminent school closures. He explained that hard conversations need to be had and one of the options is possibly making one school a K-5 and another 6-8. The District is looking at ways to be more efficient as well as allowing teachers to focus on smaller grade spans. Both short term and long term planning has to be considered in the decision making process.

# 13.4 Facility Use

The Board read the letter submitted by Peggy Zane regarding a waiver for use of the Plum Valley School Site for 4/H meetings. After a short discussion, it was agreed that the small schools would continue with status quo agreements through the remainder of the school year and starting with the 2016-17 school year requested facility use for the small schools would adhere to the District fee schedule. This would give groups requesting use the time to budget for the cost of future use.
