7.1 Antelope Elementary School Principal's Report

Mr. Thomas commended Mrs. Huskey and the Third grade for doing an incredible job with their music production.

7.2 Berrendos Middle School Principal's Report

The second annual Matador Run will be held Saturday, November 14, 2015.

Eighth grade parent information night is scheduled for October 27, 2015 at 6:00 PM in the Berrendos Cafeteria. Parents will be informed on upcoming field trips, college visits, leadership and career day opportunities.

Girls' basketball has begun and their first games will be the week of November 2, 2015.

Speeches and elections were held last week for students interested in participating in Student Council. Next week is Red Ribbon week and all students will be encouraged to dress up and participate.

Mr. Durfee took his Advisory STEM class on a field trip to the water treatment plant for a tour. Mr. Barrios' Spanish students are creating videos where students write and perform skits. Mrs. Ross' Digital Publishing class is working on Claymation. Mrs. Dent and Mrs. Huskey's Performing Arts will hold their first show on November 5, 2015 for parents and November 6, 2015 for BMS students.

Go the Distance School Assembly will be held the first week of November. Antelope 4th and 5th grade will also attend. The assembly touches on bullying, character, and making good decisions.

Mr. Weber and Mrs. Jenkins attended the Aeries Eagle Software Users' Conference last week. The conference provided information, training, and support.

7.3 Manton & Plum Valley Elementary School Principal's Report

Manton and Plum Valley Schools both had students attend Sixth Grade Science Camp. They had a fantastic time.

Plum Valley has been working on the schedule to accommodate the large grade spans. The Kindergarten class accounts for almost half of the student population and adjustments had to be made.

Recent field trips include the pumpkin patch for Plum Valley and Farm Day for Manton's K-4 class.

Both Mrs. Cottier and Mrs. Pearce have been working on student assessments at both Plum Valley and Manton schools.

Manton is gearing up for the upcoming basketball season.

7.4 Curriculum Report

i-Ready training was held District wide on October 12, 2015. Some of the topics covered were how to interpret instructional i-Ready data and ways to intervene with students. Students are completing their first growth monitoring in i-Ready.

Third-Eighth grade students will be completing EADMS benchmark assessments in reading and math.

District-wide CELDT testing will be completed this week.

Through the county consortium the district is looking to receive Title III reimbursement of up to \$6500 for Imagine Learning ELD program and training and Chico State ELA/ELD framework training.

Mrs. Cottier has been meeting with grade level staff regarding 2015 CAASPP scores and will be reviewing SBAC Grade-Level Conventions for Scoring Performance Task Full-Writes on Minimum Mondays.

7.5 Superintendent's Report

a.) **Special Presentation:** Maria Humphrey, Sixth Grade Science Camp Coordinator, presented a picture signed by all of the sixth graders to Chris Arellano. Mr. Arellano on behalf of the Grocery Outlet donated money to help with the purchase of prizes for Sixth Grade Science Camp.

Mr. Hassay reported enrollment as 767 district-wide: Antelope - 454, BMS - 247, Manton - 41, Plum Valley - 18, and CDS - 7. We still are receiving interdistrict inquiries for this year as well as requests to be put on the waitlist for 2016-2017.

The well project at Plum Valley is moving along slowly. A bid was received for the project but more paperwork from the district has been requested by the State. We are hoping to start the project by the start of the new year.

7.6 Attendance/Enrollment Report

The District ended the first month with a percent of actual attendance of 97.67%. Both enrollment and percent of actual attendance is the highest it has even been since the lapsation. Antelope has a grade level Attendance Challenge going this month. Rewards are being given to the class with the best attendance.
