The Antelope enrollment numbers continue to climb and are at 473 today.

### 10.4 Berrendos Middle School Principal's Report

Mr. Weber reported an anticipated total enrollment of 262.

Kudos was given to Stacy Pearce and Jackie Jacobs for their extra efforts assessing new students for the past two weeks.

Welcome and orientation for 6<sup>th</sup> graders and new students were held, Monday, August 14, 2017 at 6:00 PM in the Berrendos gym. Back to School Night is tomorrow.

Volleyball and open gym is being held this week. Volleyball, Cross Country, and Soccer will be starting soon.

Berrendos will once again have the same bell schedule this will be the third consecutive year without a change!

## 10.7 Superintendent's Report

Enrollment as of today stands at 857~ Antelope 474, Berrendos 265, Manton 13, Plum Valley 17, LAVA 88 ~ up 36 from the district's ending 2016-17 enrollment of 821.

Frontline, the substitute notification system, will be implemented starting with the first day of school.

A district wide inservice was held on Monday—one of the topics presented was the Antelope District's Special Education growth over the last 15 years. In 2003 the district had 25 special education students, in 2017 the district number stood at 90 that is a 360% increase.

The SUPER Program will begin tomorrow. The district believes this program will address and support some of the emotional and academic needs of students. Parents have been very receptive to the program.
